When requesting the issuance of an Extended Validation (EV) Certificate, you must complete, sign, and submit an official Extended Validation Certificate Request Form.

於申請簽發 EV SSL 伺服器憑證時，您必須以正楷英文(除部分指定中文欄位外)填寫、簽署並遞交本份正式 EV SSL 伺服器憑證申請單。

While an EV Certificate may only be issued for a single domain name, you may use this form to request more than one EV Certificate at one time by listing each domain for which you would like an EV Certificate issued. If you are requesting more than one EV Certificate using this EV Certificate Request Form, then all required information must be consistent for each domain listed in order to successfully validate and issue your EV Certificates. If you are requesting the issuance of multiple EV Certificates but the required information relative to each domain name varies, then you must fill out a unique EV Certificate Request form for each domain name.
